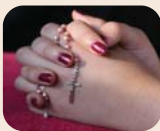

Comment from Fr. John: While actual income is less than we had budgeted for, I believe this reflects a deflect of donations to DMF which is okay in the long run. Expenses are higher because of carpet purchases for the Narthex, addition of 5 speakers to our church sound system, some unexpected boiler repairs, and additional hours devoted to grounds and facilities. A \$2500 shortage is nothing to fret about at the mid-point of the fiscal year – plenty time to re-coup (and we will! The Pastor has a crystal ball into the future).

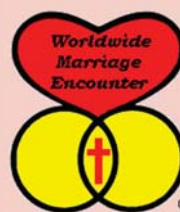

## Frequently Asked Questions about Divorce and Annulments in the Catholic Church — by Fr. John Ozella

### **What is an annulment?**

An annulment is a judgment by a diocesan court that a marriage thought to be valid according to Church law actually fell short of at least one of the essential elements required for a binding union. This doesn't deny that a relationship existed. It simply states that the relationship was missing something that the Church requires for a valid marriage.

### **How does an annulment differ from a divorce?**

A divorce is granted on the basis of events that happen after a marriage and its decrees have the force of law and are enforceable everywhere. An annulment is granted on the basis of events that happen prior to or up to the marriage (not afterwards). You receive an annulment when it's determined that either the husband or wife was unable to give full consent to marry or that there was a problem with the consent. An annulment is only enforceable within the Church; it has no outside legal effect.

### **If I got a divorce can I receive communion?**

A divorce, by itself, does not exclude you from receiving the eucharist. In fact, the Church requires you to get a divorce before you can file for an annulment. If you get a divorce and don't remarry, you can go to communion. Or if you get an annulment and remarry in the Church you can go to communion. When you can't receive the eucharist is if you get a divorce and then remarry outside the Catholic Church.

### **Is there an automatic or "no-fault" annulment?**

Yes. If a Catholic was married by a justice of the peace (not a Protestant minister or priest), the Church doesn't recognize the marriage. The process has a different name (dissolution of marriage) but the result is the same. You file a petition (your Pastor or Deacon assists you with this), the filing fee is \$25, and the decree is issued in about 30 days. No witnesses or testimony are needed. It only requires 3 documents: a petition, a copy of your marriage license and a copy of your divorce decree. A Dissolution is automatically granted; no one can contest it.

### **What is the annulment process like?**

If a Catholic had a Christian wedding of any kind, a priest or deacon helps you file a petition for an annulment. You submit an autobiography, and you're given a list of what to cover in it. The filing fee is \$75. You

meet once or twice in the office of the priest who runs the Tribunal, and usually 2 witnesses of your choosing submit a written statement. A decree is issued in about 9 months.

### **What changes did Pope Francis make last year to the annulment process?**

He made it more accessible and streamlined. Now you can file for an annulment in the Diocese where you live (you used to have to file for it either in the Diocese where you were married or where your spouse lived). The other big change is that there is no longer an automatic appeal after the judgment is rendered, bringing the annulment to finality earlier (this saves at least a month of time).

### **If I get an annulment, does that make my children illegitimate?**

Needless pain is experienced by people who don't get an annulment because they think it would make their children illegitimate. An annulment has no effect on the legitimacy of your children. Here's why.

In most countries of the world, when Catholics want to get married, they have to go through 2 marriage ceremonies. First, they get married by the state, by the government, because every government regulates marriage. They go to the equivalent of our justices of the peace and get married, and then they go off to their church and have a second, religious marriage.

But in a few progressive countries, and the United States is one of them, the government deputizes the clergy to conduct the government wedding in addition to the religious wedding, and then people only have to go through one wedding ceremony. When someone gets an annulment, that only affects the religious wedding; it has nothing to do with the state wedding. It does not nullify the state wedding.

Sacramental marriage has nothing to do with the legitimacy of children. All of the laws about the legitimacy of children are governed by the state and the state wedding. And the State says that any children born during the course of a marriage are legitimate, even if there's a divorce later. So an annulment from a religious wedding does not affect the legitimacy of children. It only voids the sacramental blessing the couple received.

### What are the consequences if you don't file or lose an annulment case, and then remarry with just a civil wedding?

Two things: you cannot receive communion, and you cannot be a communion minister. You still have all the other rights of parish membership: you can be on Councils and committees. You are welcome at Mass, can participate in the Mass and the social life of the parish, and can still be active in all of the other ministries, like Lectors, Greeters, Ushers, the choir, and so on.

But couples who have married outside of the church are not to receive communion. Some make the decision to do it anyway. It's on their conscience. Such a decision should not be made lightly. Communion is a privilege, not a right. If they present themselves in the communion line, Church law says communion ministers cannot deny them communion unless their status is so well-known that it would cause scandal.

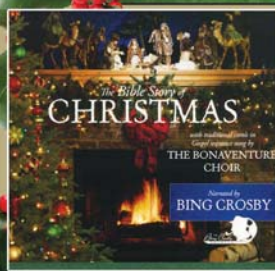
